During the regular session, Capriglione authored House Bill 2962, a bill codifying requirements for reporting on abortion complications. When the Senate returned a stronger version of House Bill 2962 to the House for a concurring vote, the speaker ruled this amendment not germane to the bill, a ruling that requires the consent of the bill author. Capriglione consented to the ruling and did not defend the Pro-Life policy. During the special session, the policy was split into two separate bills because of such political games, but this bill did pass in the special session.

✓ Amendment 5 by Farrar	Weakens the dismemberment abortion ban by adding vague terms to the “life of the mother” exception already in the bill. (Opposed by Texas Right to Life.)	3	3
✓ Amendment 2 by Klick	Bans the inhumane dismemberment abortion procedure through which a live unborn child dies from being torn limb from limb. (Supported by Texas Right to Life.)	3	3
