When the weak House Bill 2962, an abortion reporting bill, was amended with Pro-Life amendments, Sheffield publicly threatened to vote against the bill if any new Pro-Life provisions were added. He missed several Pro-Life votes, including the Schaefer amendment to protect preborn children with disabilities from painful abortions after 20 weeks. Sheffield is one of Texas Right to Life's 2017 Disappointments.

This motion to table was to kill Schaefer's amendment, demarcating loyalty to the Pro-Life cause or the anti-Life leadership of the Texas House.
