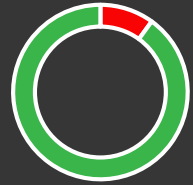

Villalba filed anti-life legislation House Bill 1938 that would have automatically made compulsory organ donors out of all Texans seeking a driver's license. Such a policy would jeopardize every Texas driver of having critical medical decisions and patient's rights limited. Also, when Representative Schaefer offered an amendment to protect preborn children with disabilities from painful abortions after 20 weeks, Villalba opposed the life-saving amendment. Villalba is one of Texas Right to Life's 2017 Disappointments.

✓ Amendment 4 by Farrar	Weakens the dismemberment abortion ban if the abortionist claims that dismemberment was safer. (Opposed by Texas Right to Life.)	3	3
✓ Amendment 5 by Farrar	Weakens the dismemberment abortion ban by adding vague terms to the “life of the mother” exception already in the bill. (Opposed by Texas Right to Life.)	3	3
✓ Amendment 2 by Klick	Bans the inhumane dismemberment abortion procedure through which a live unborn child dies from being torn limb from limb. (Supported by Texas Right to Life.)	3	3
✓ Amendment 7 by S. Davis	Strikes half of SB 8, including the ban on the purchase and sale of baby body parts, as well as fetal burial and cremation requirements. (Opposed by Texas Right to Life.)	1	1

X Motion to Table Amendment 22 by Schaefer	Representative Schaefer offered an amendment supported by Texas Right to Life to close a loophole in current Pro-Life laws that allows preborn children with disabilities to be killed by abortion after 20 weeks of development. This motion to table was to kill Schaefer's amendment, demarcating loyalty to the Pro-Life cause or the anti-Life leadership of the Texas House. (Motion to Table Opposed by Texas Right to Life.)	0	6
