Representative Shaheen’s amendment to the State Budget’s Bill helped solidify advertising funding for the Healthy Texas Women program. Later in the budget negotiations, he authored the motion to instruct the conferees to keep strong budget-wide language to prohibit any state funds from going to abortion providers and their affiliates that was passed in the House version of the bill. Representative Shaheen was also a member of the newly formed Texas Freedom Caucus in the House who secured and negotiated every Pro-Life victory in the House this session.

✓ Amendment 4 by Farrar	Weakens the dismemberment abortion ban if the abortionist claims that dismemberment was safer. (Opposed by Texas Right to Life.)	3	3
✓ Amendment 5 by Farrar	Weakens the dismemberment abortion ban by adding vague terms to the “life of the mother” exception already in the bill. (Opposed by Texas Right to Life.)	3	3
✓ Amendment 2 by Klick	Bans the inhumane dismemberment abortion procedure through which a live unborn child dies from being torn limb from limb. (Supported by Texas Right to Life.)	3	3

This motion to table was to kill Schaefer's amendment, demarcating loyalty to the Pro-Life cause or the anti-Life leadership of the Texas House. (Motion to Table Opposed by Texas Right to Life.)	6	6
