Representative Rinaldi served as the Pro-Life Whip during the 85th Sessions of the Texas Legislature. In this role, he organized and oversaw the passage of Pro-Life motions, amendments, and bills while negotiating with House leadership at multiple critical junctures. He also authored several Pro-Life amendments, including one budget-wide rider that prohibited abortion providers and their affiliates from receiving any state funding in the State's Budget Bill. He also authored a Pro-Life amendment fixing and strengthening a disastrous bill carried by Byron Cook on the definition of abortion. Representative Rinaldi was also a member of the newly formed Texas Freedom Caucus in the House who secured and negotiated every Pro-Life victory in the House this session. Representative Rinaldi is one of Texas Right to Life's 2017 Pro-Life Heroes.
