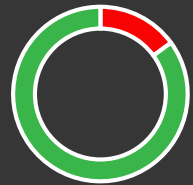

When Representative Schaefer offered an amendment to protect preborn children with disabilities from painful abortions after 20 weeks, Shine opposed the life-saving amendment. He later entered a journal statement that his vote registered incorrectly and he intended to vote for the amendment; however, this journal entry does not change the official vote count that defeated the amendment.

✓ Amendment 3 by Turner	Weakens the dismemberment abortion ban with an exception to dismember unborn children conceived through sexual assault or incest. (Opposed by Texas Right to Life.)	3	3
✓ Amendment 4 by Farrar	Weakens the dismemberment abortion ban if the abortionist claims that dismemberment was safer. (Opposed by Texas Right to Life.)	3	3
✓ Amendment 5 by Farrar	Weakens the dismemberment abortion ban by adding vague terms to the “life of the mother” exception already in the bill. (Opposed by Texas Right to Life.)	3	3
✓ Amendment 2 by Klick	Bans the inhumane dismemberment abortion procedure through which a live unborn child dies from being torn limb from limb. (Supported by Texas Right to Life.)	3	3
✓ Amendment 7 by S. Davis	Strikes half of SB 8, including the ban on the purchase and sale of baby body parts, as well as fetal burial and cremation requirements. (Opposed by Texas Right to Life.)	1	1

This motion to table was to kill Schaefer's amendment, demarcating loyalty to the Pro-Life cause or the anti-Life leadership of the Texas House. (Motion to Table Opposed by Texas Right to Life.)	0	6
