X Amendment 4 by Farrar	Weakens the dismemberment abortion ban if the abortionist claims that dismemberment was safer. (Opposed by Texas Right to Life.)	0 (UA)	3
X Amendment 5 by Farrar	Weakens the dismemberment abortion ban by adding vague terms to the "life of the mother" exception already in the bill. (Opposed by Texas Right to Life.)	0 (UA)	3

This motion to table was to kill Schaefer's amendment, demarcating loyalty to the Pro-Life cause or the anti-Life leadership of the Texas House. (Motion to Table Opposed by Texas Right to Life.)	0	6
