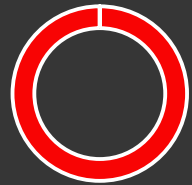

## Senate Bill 8: Pro-Life Omnibus Bill (regular session)

| <b>X</b> Amendment 3 by Turner              | Weakens the dismemberment abortion ban with an exception to dismember unborn children conceived through sexual assault or incest. (Opposed by Texas Right to Life.)   | 0             | 3                |
| <b>X</b> Amendment 4 by Farrar              | Weakens the dismemberment abortion ban if the abortionist claims that dismemberment was safer. (Opposed by Texas Right to Life.)  | 0             | 3                |
| <b>X</b> Amendment 5 by Farrar              | Weakens the dismemberment abortion ban by adding vague terms to the "life of the mother" exception already in the bill. (Opposed by Texas Right to Life.)   | 0             | 3                |
| <b>X</b> Amendment 2 by Klick               | Bans the inhumane dismemberment abortion procedure through which a live unborn child dies from being torn limb from limb. (Supported by Texas Right to Life.)   | 0             | 3                |
| <b>X</b> Amendment 7 by S. Davis            | Strikes half of SB 8, including the ban on the purchase and sale of baby body parts, as well as fetal burial and cremation requirements. (Opposed by Texas Right to Life.)  | 0             | 1                |
| <b>X</b> Amendments 9-13 & 21               | A series of six weakening amendments to SB 8 offered by anti-Life Democrats. (Opposed by Texas Right to Life.)  | 0             | 1                |
| <b>X</b> Amendment 15 by Cain and Oliverson | Strengthens guidelines to prohibit donation of placenta and umbilical cord blood from being sold or donated after an elective abortion. (Supported by Texas Right to Life.)   | 0             | 1                |
| <b>X</b> Amendment 19 by Schaefer           | Requires abortionists to submit monthly abortion reports electronically and directs the Department of State Health Services to develop an electronic system for abortion reporting. (Supported by Texas Right to Life.) | 0             | 1                |

This motion to table was to kill Schaefer's amendment, demarcating loyalty to the Pro-Life cause or the anti-Life leadership of the Texas House. (Motion to Table Opposed by Texas Right to Life.) | 0             | 6                |
| <b>X</b> Second Reading Vote                      | House floor vote to pass Senate Bill 8 to third reading, the final step in passage. (Supported by Texas Right to Life.)  | 0             | 3                |
