Gooden's House Bill 3124 was amended in the Senate to include Pro-Life Health Insurance Reform, which was killed by Byron Cook in the House Committee on State Affairs. When the Senate returned a stronger version of House Bill 3124 to the House for a concurring vote, the speaker ruled this amendment not germane to the bill, a ruling that requires the consent of the bill author. Gooden consented to the ruling and did not defend the Pro-Life policy. Also, when Representative Schaefer offered an amendment to protect preborn children with disabilities from painful abortions after 20 weeks, Gooden opposed the life-saving amendment. Gooden is one of Texas Right to Life's 2017 Disappointments.
